NOW THIS INDENTURE WITNESSES AS FOLLOWS :-

- 1- In order to effectuate this said desire the SETTLOR (The Government of Himachal Pradesh) has handed over the property of Shri Mahamaya Balasundari ji Temple Tehsil Nahan, District Sirmour, H.P., to the Trust by way of notification on 01-05-2002 vide notification number LCD-F(1)/2002 being State Government having opinion that it is expedient and necessary in the public interest to take steps for better administration and for the protection and preservation of properties appurtenant to the aforesaid Temple under the H.P. Hindu Public Religious Institutions and Charitable Endowments Act 1984 , to hold and stand possessed for the same referred as Trust Fund. The Trust shall be deemed to have commenced w.e.f. 01-05-2002 for all practical purposes.
- 2- Whereas the SETTLOR has a view to serve the society in larger public interest for the development of Shrine including providing basic amenities to the visitors and welfare of mankind for charitable activities without discrimination of religion, colour, cast and creed out of the funds vests with the Trust in various bank accounts which are received and possessed of and which he set apart for the purpose as detailed in the AIMS and Objects .

And whereas the TRUSTEES have unanimously agreed to hold and apply the said funds including all additions and accretions hereto referred to as the "TRUST property /Fund" for the objects of the provisions contained in this deed. The Trust shall hold the Trust property upon Trust and to permit the same to be used and appropriated in conformity with provisions of Trust rules and the Act.(H.P. Hindu Public Religious Institutions and Charitable Endowment Act 1984)

AND whereas with a view to and the purpose of constituting the TRUST permanently as an irrevocable TRUST for the purpose of carrying on the objectives of the TRUST as mentioned hereinafter under the "Aims and Objectives" clause for the deed of TRUST.

1- NAME AND OFFICE OF THE TRUST

- a) The name of TRUST shall be " SHRI MAHAMAYA BALASUNDRI JI TEMPLE TRUST TRILOKPUR , TEHSIL NAHAN, SIRMAUR, H.P.'
- b) The Office of the TRUST shall be located at Village Trilokpur Tehsil Nahana, District Sirmaur, H.P.
- c) The Jurisdiction of the TRUST shall cover the District of Sirmaur, H.P.

INTERPRETATION

- a) The "SETTLOR" means the Government of Himachal Pradesh through Deputy Commissioner Sirmour appointed and defined under section 2(e) and 3(3) of H.P. Hindu Public Religious Institutions and Charitable Endowment Act 1984 .
- b) The "Act" means H.P. Hindu Public Religious Institutions and Charitable Endowment Act 1984.
- c) The "TRUST" means the TEMPLE TRUST constituted by the Commissioner (Temple) under the provisions of the Act ibid. and by this deed .
- d) The "Joint Commissioner(Temple) means the Officer appointed and defined under section 2(i) and Section 3(4) of the Act ibid.
- e) The " Board " shall mean the Board of Trustees created by the Deed who are appointed by the Commissioner (Temple).
- f) "Trust Property" shall include every kind of property movable and immovable owned by the TRUST and mentioned in account books and other documents in the custody and control or that ought to be in the custody and control of the TRUST.

2- AIMS AND OBJECTS OF THE TRUST

The Charitable objects as per provisions mentioned in 2(15) of the Income Tax Act 1961 :-

- (i) Relief to poor
- (ii) Medical relief
- (iii) Education
- (iv) Yoga
- (v) Preservation of environment
- (vi) Preservation of monuments or places or objects of artistic or historic interest
- (vii) The advancement of any other object of general public utility but not involving the carrying on any activity for profit and for such purposes and lastly to do all other acts a may be incidental , conducive to the attainment of the object or any purpose , Public Charitable .

Since , the Trust is a notified Trust by the Government of Himachal Pradesh on 01-05-2002 under The Himachal Pradesh Hindu Religious and Charitable Endowment Act 1984, all the activities are run as per provisions mentioned in the Act and directions from the Government time to time and also as per Income Tax Act 1961 & to carry on charitable activities along with providing basic amenities and security and safety to the lakhs of pilgrims. Besides this , the Trust will also carry on charitable activities for the welfare of poor including pilgrims to the Trilokpur Shrine , c/o rain shelters, Bye pass road, Toilet complexes and shall be provided free of cost by the Trust in larger public interest.

- (i) The benefit of the objects would be available to general public irrespective of caste, creed, language, religion , region ,sex.

3- CHARITABLE ACTIVITIES

1. That the Trust will carry on Charitable activities as per provision mentioned in 2(15) of the Income Tax Act 1961 in larger public interest without discrimination of religion, colour ,cast and creed. Besides this, medical help to Poor's, including pilgrims to the Trilokpur Shrine, rain shelters, Bye pass road, Toilet complexes shall be provided free of cost by the Trust in larger public interest and with a

view to preserve monuments, artistic objects etc., the Trust is running a multistory museum at Trilokpur.

- (i) With a view to facilitate and provide basic amenities to the lakhs of pilgrims who visit Shrine around the year and especially during Chaitra (March-April) and Aashwin (Sept-Oct) Navratra Fairs, the Trust will incur expenditure related to efficient control of crowd, law & Order and safety of pilgrims of all religions i.e. deputing security personnel's /Home Guards and casual labour on payment basis, maintenance of Toilet complex's, drinking water, Street lighting, Sarai /Yatri Niwas and Bhandara shed/buildings etc.
- (ii) The Trust will provide Bhandara facility around the year free of cost to facilitate pilgrims without discrimination of religions, color, caste and creed to pilgrims.
- (iii) The Trust will provide grant in aid to physically and Mentally retarded (Divyang's) i.e. Aashtha Charitable Organization at Nahan and to the Society's established for orphanage etc. and various help to poor falling under below poverty line or a person having annual income less then 48000 per annum for which income certificate shall be issued by the Executive Magistrate.
- (iv) The Trust will provide grant for the running & maintenance of a "Gaushala" including stray cattle's as per Agreement with Society against. Cruelty towards Animals at Nahan wherein nourishment and maintenance expenses are borne by the Trust. Besides Gen. Repairs and maintenance is also done as per requirement of said Gaushala. Beside this, as per Act, the Trust is bound to pay 15% to the District Administration out of its net income after recurring expenses for the safety and security of GOVANSI under section 22(2)g as inserted after amendment in 2018 in the H.P. Hindu Religious Institution and Charitable Endowments Act 1984.
- (v) The Trust has adopted around 5 km area wherein complete sanitation of village Trilokpur, free electric street lighting is provided and maintained by the Trust to facilitate large number of pilgrims around the year.

- 2- That there will be no infringement to the 1st proviso to Section 2(15) of the Income Tax Act 1961 by the Temple Trust Trilokpur, Sirmour, H.P. which defines the Charitable purpose

- 3 The Trust will work solely for Charitable purpose to facilitate pilgrims and poor families and will comply with all the requirements of law to the tune of section 17 of H.P. Hindu Religious Institutions and Charitable Endowment Act 1984 and defined as per Income Tax Act 1961.

4- RAISING OF FUND AND EXPENDITURE:

- (1) The founder has in the first instance provided the property of Shri Mahamaya Balasundari Ji Temple and the amount, valuables, movable and immovable property which our respective accounts ledger, cash book and stock ledgers shows to the trust after its formations.
- (2) With a view to achieve any or all the above objects to raise funds through donations, grants and contributions and to obtain and receive deposits and loans from Banks and other Financial Institutions, Individuals, associations, firms whatever and to invest and deal with the money and funds belonging to the TRUST not immediately required in such manner as may from time to time be determined by the TRUST subject to the provisions of the Law of the land, and to take on lease or purchase or accept by way of gift and land, building or any other property both movables and immovable's and to remunerate any person, firm or institutions for services rendered to the TRUST in any capacity and to pay out the funds of the Trust all costs, charges, expenses incidental to the establishment, registration and advertisements of this Trust and to adopt and take such other lawful means as may be incidental and conducive to the accomplishment of all or any of the above objects and shall also receive grants and donations from organization, institutions or agencies and individuals according to the prevailing Law of the land.

5- CONTROL OF THE TRUST:

The properties and funds shall vests in the TRUST constituted by persons executing the Deed of Trust. The number of members of the TRUST shall not be exceeding 25.(Twenty Five)being limited to this extent under section 18 of the Act ibid. The appointment and removal of the Trustees shall be by the Commissioner (Temple) under the H.P. Hindu Public Religious Institutions and Charitable Endowment Act 1984, If there are vacancies at the time of execution of this deed the same can be filled up by co-option of the TRUST of Trustees.

(i) OFFICE BEARERS OF THE TRUST shall be as below:-

- 1) Commissioner(Temple) cum Deputy Commissioner Sirmour at Nahan
- 2) Joint Commissioner(Temple) cum Sub Divisional Officer(Civil) at Nahan
- 3) Temple Officer cum Tehsildar Nahan being Drawing and disbursing Officer .

Provided that the TRUST is authorized to propose any other posts of office bearers and elect other office bearers to fill up the posts among the Trustees after taking approval from the Chief Commissioner (Temple) Language ,Art and Culture Department as defined in act ibid.

7- VACANCIES: A VACANCY SHALL ARISE AMONG THE

- a) When a Trustee dies
- b) When he / she resigns
- c) When he / she is convicted of any criminal offence involving moral turpitude

The TRUST then by a 2/3rd majority of the existing Trustees attended the meeting convened for the purpose, shall fill up the vacancies arising in the TRUST and also increase and include more Trustees as per Act i.e. H.P. - d) To erect or cause to be erected buildings, Yatri Niwas, Toilet Complex, Rain Shelters, Canopy Sheds, Roads, drainage system, sewerage system or building equipments and machinery for the benefit and attainment of the objects of the Trust.
- e) To sell, transfer, exchange, alienate or mortgage movable properties belonging to the Trust strictly as per provisions of H.P. Financial Rules 2009.
- f) To manage administer and control properties and all assets of the Trust directly or indirectly and all institution connected with the Trust.
- g) To demand, call for and realize money and other assets due or belonging to the Trust and issue receipts and vouchers for the receipt of the same.
- h) To employ and creation of new post for necessary staffs after approval from the Chief Commissioner (Temple) for the efficient management, administration and running of the Trust in general and for the institution in particular and for the purpose of carrying out the objects of the Trust on such terms as may appear proper to the trustees and to delegate and to allot to such staff from time to time such powers and duties as may be necessary in the usual course of activities.
- To appoint from time to time and at any time to suspend, dismiss, remove or discharge any person under their control including clerks, accountants, Peon's etc and to re-employ them with such powers and duties and upon such either by giving one month notice or by giving one month salary as the TRUST shall think proper as per Employees Bye Laws and R&P Rules, new posts if any shall only be added after taking approval of the Chief Commissioner (Temple) as empowered in act ibid.
- j) The TRUST shall have the full power to make, amend, delete or rescind rule and by-laws of the Trust for overall managerial

and efficient manpower management subject to the provision of 34 of the act ibid. In case of Recruitment and Promotion rules, a proposal shall be sent to the Chief Commissioner(Temple) who has been empowered in the H.P. Hindu Public Religious Institutions and Charitable Endowment Act 1984 (as amended in 2007).

- k) To do all acts and things which are connected with the administration of the Trust in general and of the institutions in particular and which are deemed by the trustees to be in the best interest of the Trust and desirable.

10- TRUSTEES RESPONSIBILITIES

The Official Trustees shall, in addition to and without prejudice to responsibilities under applicable law, be responsible for the following:-

- (i) Fulfilling the objects and purpose of the Trust;
- (ii) Ensure the proper application of the funds;
- (iii) Preparing and submitting all filings ,accounts and returns as required under any applicable law;
- (iv) All the Trustees shall provide all reasonable assistance as may be required from time to time including suggestions and proposal to fulfil the objects for which Trust exists and ensure presence in the meeting of the Trust to decide the proposals submitted in larger public interest.
- (v) The Trustees are bound to obey orders made by the Commissioner (Temple) as under the provisions section 8 of the Act ibid.

11- FUNCTIONS OF THE OFFICE BEARERS:

- (i) RECEIPTS OF CONTRIBUTIONS AND BANK ACCOUNTS :

All the money should be received only on account of or in the name of the TRUST and receipts should be issued under the seal of

the Trust and must be signed by the Commissioner (Temple) or Joint Commissioner(Temple) or Temple Officer or the persons authorised by the TRUST by a resolution recorded in the minute book. No money or property shall be received or used except for the purpose and objects of the Trust. The Bank accounts shall be opened in the name of the Trust and shall be operated by the Temple Officer (Tehsildar) being Authorised Signatories on behalf of the Trust being Drawing and Disbursing Officer(DDO).

- (ii) Preparation and maintenance of registers as per section 6 of the Act
- (iii) Annual verification of the registers as per section 7 of the Act.
- (iv) The Trustees shall furnish accounts , returns etc as per section 10 of the Act.
- (v) Inspection of property and document shall be as per section 11 of the Act.
- (vi) Preparation of Budget shall be strictly as per section 22 of the Act. The estimated budget shall be placed before Trust before closing of a financial year.
- (vii) Maintenance of Accounts shall be strictly as per section 23 of the Act ensuring regular accounts of all receipts and disbursements. The expenditure shall be in accordance to budget approved by the TRUST under section 22 of the Act.
- (viii) The Trustees shall administer its affairs and apply its funds and properties in accordance with the terms of the Trust, the custom or usage of the institution and lawful direction which a competent authority may give in respect thereof.

12- TRUST MEETING

1. The Commissioner (Temple) cum Deputy Commissioner shall be Chairperson of the TRUST and shall preside over the meetings of the TRUST.
2. Any person appointed as a Trustee shall act in a pro bono capacity i.e. services rendered to non-profit organization free and voluntarily.

3. The Trust shall meet at least thrice in a year. The Commissioner (Temple) shall be authorised to call meeting urgently required to discuss on any important matter related to the Trust
4. The minutes of the proceedings of every meeting shall be entered into a book manually or electronically and shall be pasted in a book to keep track of decisions and reviews. The proceedings shall be signed by the Chairperson of said meeting countersigned by two other official Trustees i.e. Joint Commissioner (Temple) and Temple Officer.

13- IMMOVABLE PROPERTIES OF THE TRUST

No immovable property belongs to the Trust shall be sold, exchanged, transferred, converted, mortgaged or alienated in any manner whatsoever except when such exchange, transfer, conversion or alienation :

- i) Is imperative in the interest of the Trust and Institutions and Department connected therewith,
- ii) Is not likely to adversely affect to any extent whatsoever the existence and benefit of the Trust, Institution and departments connected therewith an object of the Trust, and

14- SUITS AND LEGAL PROCEEDING:

The TRUST or any one or more of the Trustees may apply for advice or the directions to the Court as occasion may arise. The TRUST of Trustees may apply may sue or to be sued in the name of the Temple Officer of the TRUST. The TRUST may by a resolution passed specially or generally in that respect at any time and from time to time authorize Temple Officer or any of the Trustees by power of Attorney or otherwise.

- i) To institute, conduct, defend, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claim or disputes, or against the Trust or Trustees or against its officers or employees concerning the affairs of the Trust and to sign and verify vakalat, plaints, statements, affidavits and other proceedings before all Courts, Tribunals and other Government authorities both Central and State.
- ii) In entering into any agreement or contract or in executing and registering any document,
- iii) Generally in doing and performing any act, deed, matter of things whatsoever which has to be done, executed and performed by the TRUST of Trustees or Trustees as the case may be in relation to any property, business affairs and matters of the Trust and / or of the TRUST and/ or Trustees as in/are principal / principals.

v) Protection of action taken under section 26 of the Act :

(1) No officer or servant of the Government shall be liable in any civil or criminal proceedings in respect of any act done or purporting to be done under this Act or under the rules made thereunder, if the act has been done in good faith and in the course of execution of the duties imposed or in discharge of the functions assigned by or under this Act.

17- AREA OF OPERATION

The area of operation of the objects shall be confined within the territory of India.

18- INVESTMENT

- (i) The investment of the Trust assets shall be made as per the provisions of the Income Tax act, 1961.
